1. Credits

The Client agrees to credit the Author each and every time an image is used unless otherwise stated by the Author. If the Client fails to do this, an additional 100 % of the license fee will be payable.

The Author may be credited in the following ways unless otherwise authorized by the Author in writing:

- For multiple contributions to a magazine or book, the Author shall receive the following name credit in print: “Les Gallagher - *fishpics & ImagDOP*, University of the Azores”.
- For individual contributions to a magazine or book, the following copyright notice shall appear adjacent to each work: “Les Gallagher - *fishpics & ImagDOP*, UAç”.

2. Payment

Payment is due within 30 days of receiving an invoice. The grant of any license or rights of copyright is dependent upon and conditional to the receipt of the full payment.

3. Default in Payment

The Client shall be responsible for the collecting of any legal fees resulting from default in payment.

4. Sales or Value Added Tax

The Client shall be responsible for the payment of sales or value added tax, if any such tax is due.

5. Grant of Rights

The grant of reproduction rights is dependent upon and conditional to the receipt of full payment.

6. Complimentary Copies

The Client agrees to provide the Author with at least 2 complimentary copies of any publication in which the assigned work appears and that these copies will be supplied within two months of the said publication.

7. Limited Exposure

It is expressly agreed that the Client will not subject any of the assigned work to public exposure on the Internet unless authorized to do so by the Author in writing. If electronic rights are granted, all images that are larger than 500 pixels width must carry the Fishpics watermark in addition to the specified credits unless otherwise authorized by the Author in writing.

8. Alterations

Alteration to artwork shall not be made without the written authorization of the Author. If alterations are required following the acceptance of the artwork, the Author retains the right to charge a payment over the original amount.

9. Unauthorized Use

The Client will reimburse the Author for any claims and reasonable legal expenses, including lawyer’s fees that result from a) the Clients use of artwork that was not requested in writing and or b) the use of artwork that was not granted in writing by the Author.

10. Warranties of Originality and Liability
